Terms and Conditions for the Annual Donation Draw

1. Eligibility

- **1.1.** The Draw is open to all members of the public.
- **1.2.** Employees of Catholic Welfare Services are not eligible to participate.

2. Ticket Purchase

- **2.1.** There are 2 types of tickets available:
 - Physical Tickets: Distributed through schools and parish churches.
 - **E-Tickets**: Available for purchase by members of the public through the CWS Donation Draw platform hosted on www.catholicwelfare.org.sg.
 - Each ticket must be completed with the buyer's full name, contact number, email address and last four characters of their NRIC (for verification).

3. Ticket Pricing:

3.1. The price for each ticket (both physical and electronic) will be \$2.

4. Instructions to Sellers of Physical Donation Draw tickets

- **4.1.** Ensure all buyer details are written clearly on the counterfoils of the tickets.
- **4.2.** If a buyer purchases an entire book of tickets, mark "whole book" on the first ticket's counterfoil.
- **4.3.** Provide the buyer with their tickets after purchase.
- **4.4.** Report any lost tickets or counterfoils to the participating organization's (eg Parish or school) person-in-charge immediately.
- **4.5.** Return all counterfoils and collected monies to the designated person of the participating organization by the specified deadline.

5. Draw Date and Duration

- **5.1.** The Draw will be held on 18 December 2025.

- **5.4.** The public is welcomed to witness the draw in person.

 - NRIC

7.1. Winners who have lost the winning tickets must inform CWS in writing and/or submit a copy of their police report.

8. Acknowledgement of Receipt of Prize

- **8.1.** Prize winners must sign a Prize Acknowledgement Form upon receiving their prize.
- **8.2.** The date of prize collection will be recorded by CWS.
